The symbols related to the unconscious, the characters in the stories of Edgar Allan Poe. Symbols which present in the short story are derived from the unconscious character, and remind the characters in a traumatic event or influence the actions and behavior in the story. Therefore, the researcher makes the title Psychological Horror in Edgar Allan Poe's The Lighthouse in order to find out kind images of these main characters.

## RESEARCH METHOD

### 1. Research Design

#### Research Approach

The researcher used qualitative research to analyze the issue. Qualitative research is a study that provides explanation in the form of descriptions from the data that have been obtained.

The core of qualitative analysis lies in these related processes of describing phenomena, classifying it, and seeing how our concepts interconnect. It also deals with meanings. Meanings are mediated mainly through language and action. (Dey, 1993: 11 & 31)

The researcher uses this approach to describe the psychological horror character in Edgar Allan Poe's The Lighthouse and Benjamin Cooper's The Lighthouse Keeper. After describing, the author continues to analyze the entire data with the theories that has been discussed earlier.

#### Research Method

Comparative literature is a method that compares differences to get similarities.

This method compared two or more, even are not limited things. It also helps to find out human expression from any authors with having similar ideas. "In brief, it is the comparison of one literature with another or others, and the comparison of literature with other spheres of human expression." (Basnett, 1993: 31)

The similarities will be the comparison between the sources. The comparative method is able to use any theories as long as this research needs them. In addition, the unlimited area and object in

comparative literature facilitates the researcher to carry out this research.

Comparative literature can also be a bridge among different objects because the data obtained from various objects that can relate each other through the comparison process.

According to Bassnett (1993, pg. 32) "Crucial to remark argument was the notion that comparative literature should not be regarded as a separate discipline with its own laws, but should rather be seen as an auxiliary discipline, as a bridge between subject areas". The researcher will analyze the comparison from data of grotesque between main characters in three literary works.

#### Source of Data

These data are research object. These will be the substances to be analyzed by the researcher.

- a. Short Story *The Lighthouse* by Edgar Allan Poe.
- b. Movie *The Lighthouse Keeper* by Benjamin Cooper.

#### Technique of Collecting Data

In this research, the data from three research objects were collected in several ways. According to Moleong, there are several ways to collect data, namely reading objects, making signs or taking notes, compiling data, and reading other sources such as journals or other books that relate with this research (Moleong, 2007). The researcher carries out some of these methods.

- a. Reading the three text of objects.
- b. Making signs or taking notes the quotes that related with research scope by using the colorful paper mark or bookmark in each page of object based the reading result.
- c. Arranging or collecting data that related with the topic of discussion in this research.
- d. Comparing data of five different perspectives or objects to get the similarity.
- e. Collecting additional data from other sources, such as books, journals, and articles that related with the research.

- e. The last step is a conclusion from the overall discussion of the research.

## RESULT AND DISCUSSION

The writer studied three short stories as the object of the study, they were: Edgar Allan Poe's *The Lighthouse* and Benjamin Cooper's *The Lighthouse Keeper*. Theory of character, and gothic used as the theoretical frame work of the research.

The goals of the research were to find and understand gothic idea that revealed on the Poe's short stories characters. The writer found out that Edgar Allan Poe's characters in his short stories were supported by the gothic idea.

Poe found several things that aimed to the gothic tendencies (such murky atmosphere of horror, gloom, macabre, mysterious, violent incidents, grotesque, irrational violence, desolation, and decay) that Poe revealed in his characters. This research covers several different sources and genres.

These differences lead to theories that will be used, namely horror character from Harold Bloom and Blake Hobby (2009) and Maria Haar (1983), character from Abrams (1999), character is a form of morality, character, which makes a feature of someone.

This feature makes each character distinguishes with another characters. As

for the three research objects on *The Lighthouse* and *The Lighthouse Keeper* which have different issues in each characters.

"Characters are the persons represented in a dramatic or narrative work, who are interpreted by the reader as being endowed with particular moral, intellectual, and emotional qualities by inferences from what the persons say and their distinctive ways of saying it— the dialogue— and from what they do—the action." (Abrams, 1999, pg. 32-33)

The characters represented something that happened at the works were written. It could be related with society, architecture, or inner self of human.

According to Young in his essay *Representation in Literature*, "Nowadays, when people talk about representation in connection with the arts, they usually have in mind the visual arts and pictorial representation." In literary works, the representation can be seen through the texts.

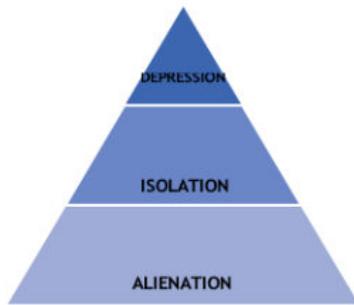
The term "novel" is now applied to a great variety of writings that have in common only the attribute of being extended works of fiction written in prose." (Abrams, 1999, pg. 190).

Then the second stage is isolation, which is when the main character is lonely and starts consuming too much alcohol. And the last is the depression stage when the main character becomes alcoholic and often fantasizing non-sense thing.

#### CONCLUSION AND SUGGESTION

Researching a writer's biography beforehand is one way to understand why someone's literary work has strong characteristics compared to other literary works.

out that Edgar Allan Poe's characters in his short stories were supported by the gothic idea.

He found several things that aimed to the gothic tendencies (such as murky atmosphere of horror, gloom, macabre, mysterious, violent incidents, grotesque, irrational violence, desolation, and decay) that Poe revealed in his characters.

The symptoms of schizophrenia are indeed seen in the main character's behavior and utterances which indicates that they are schizophrenic.
